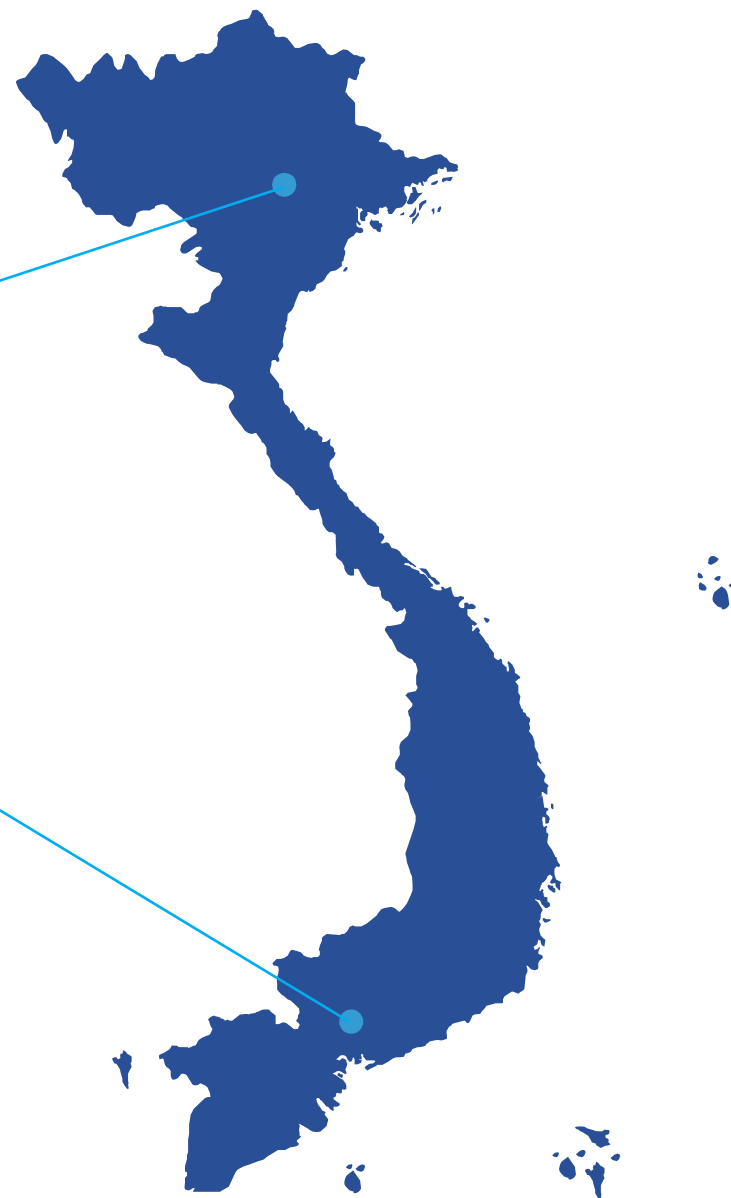

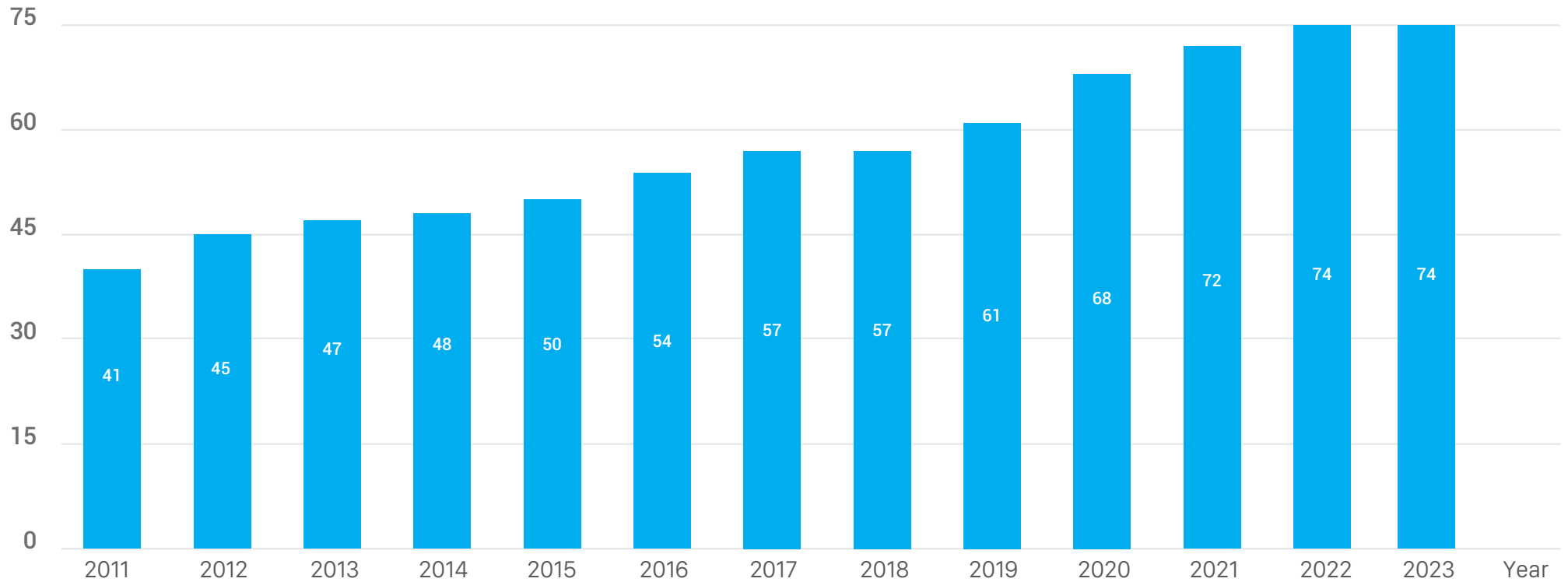

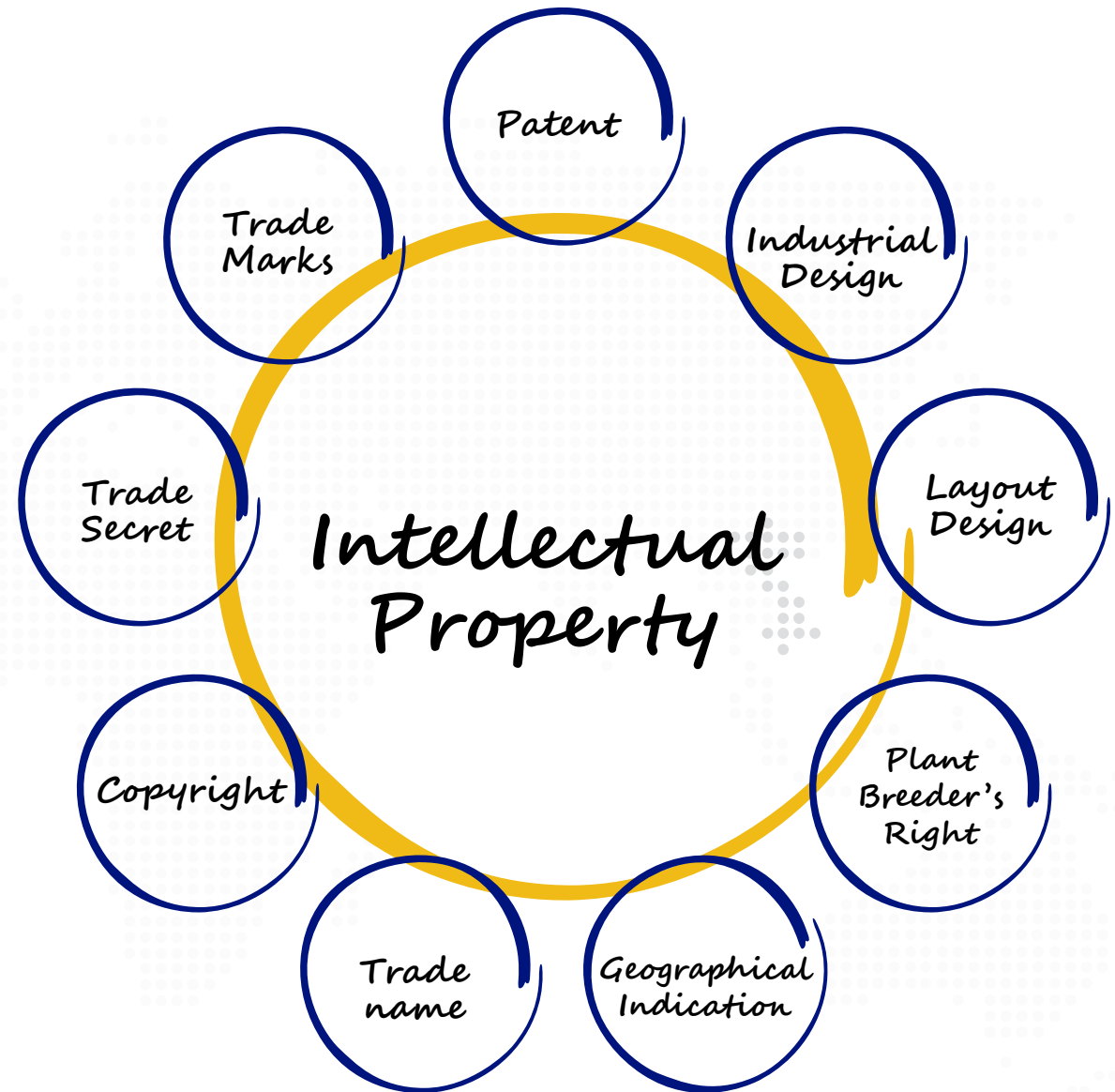

We have good relationships with the Science and Technology Departments in Vietnam provinces and cities

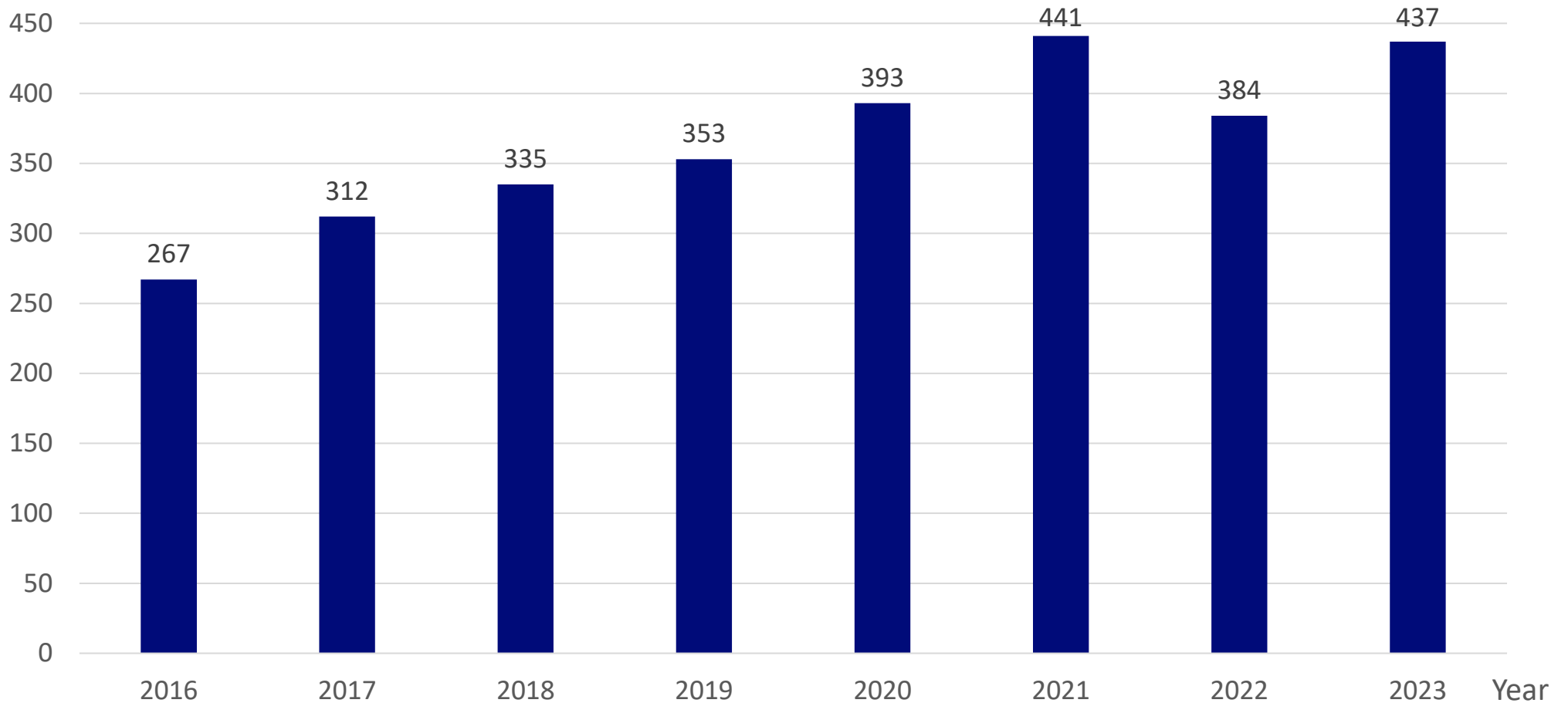
All patent cases and relevant matters, such as deadline management and conflict check, are handled with the support of a dedicated software

We have good relationships with the Vietnamese Patent Office and Examiners

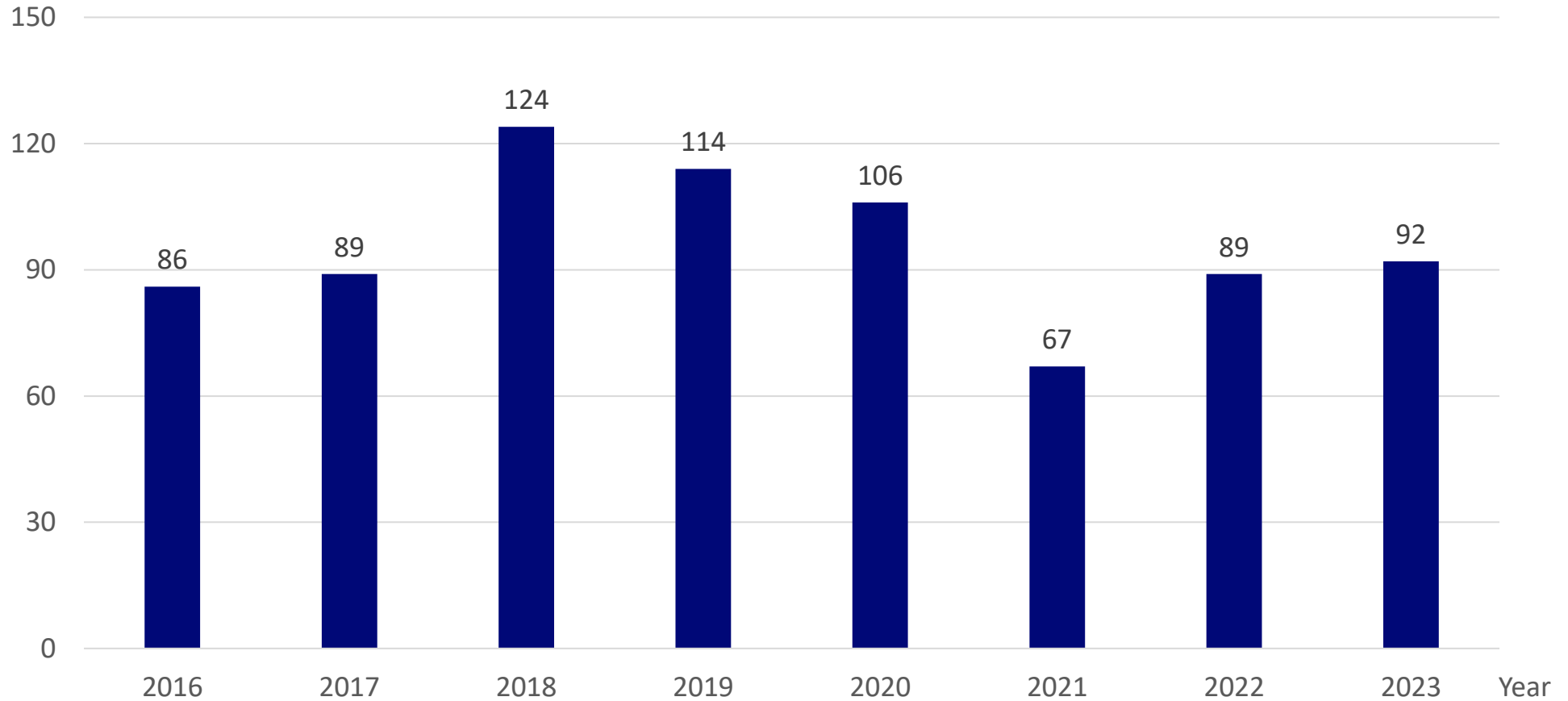


Patent Filing Statistics

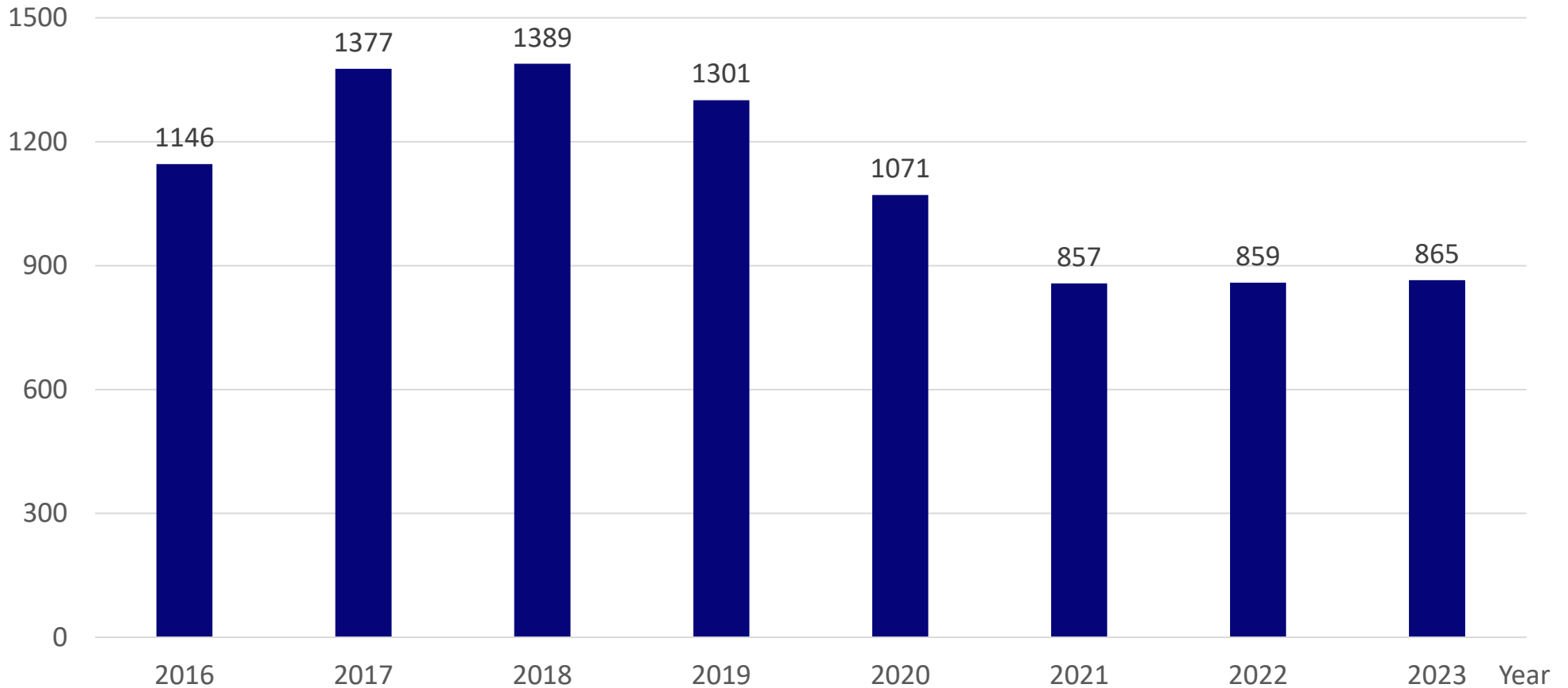

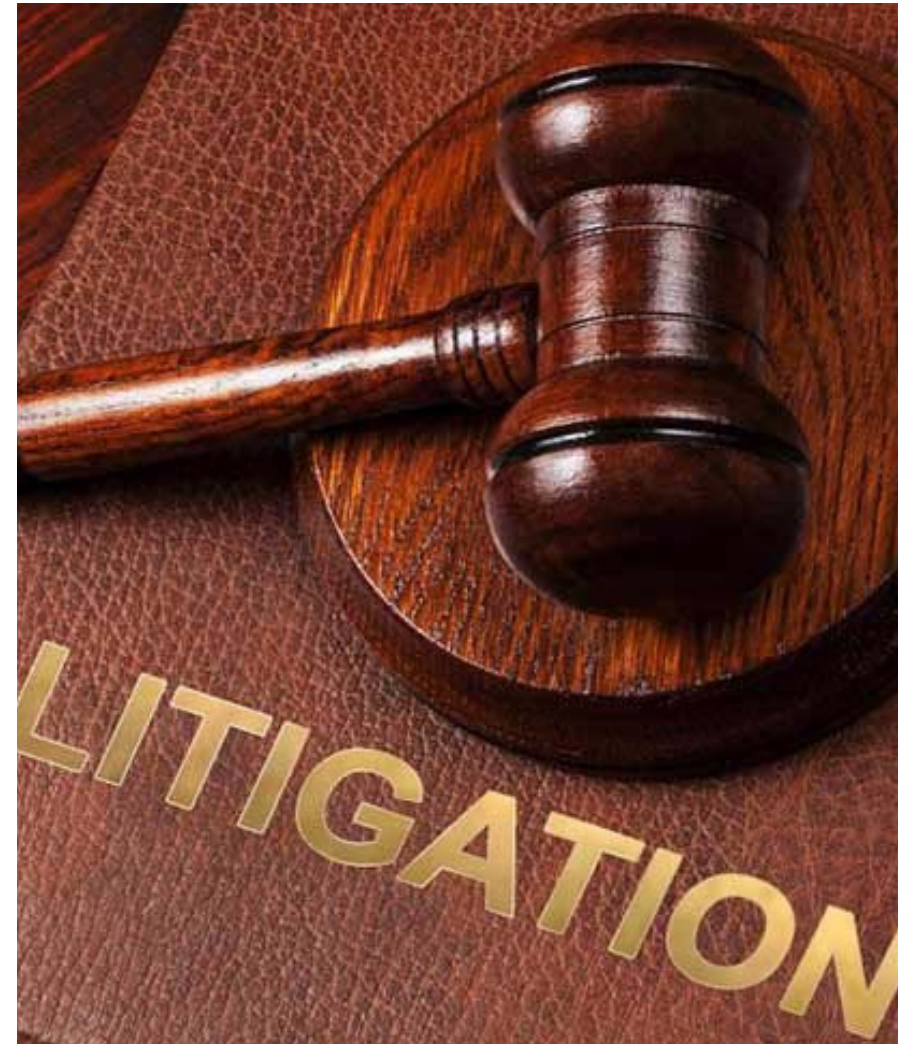

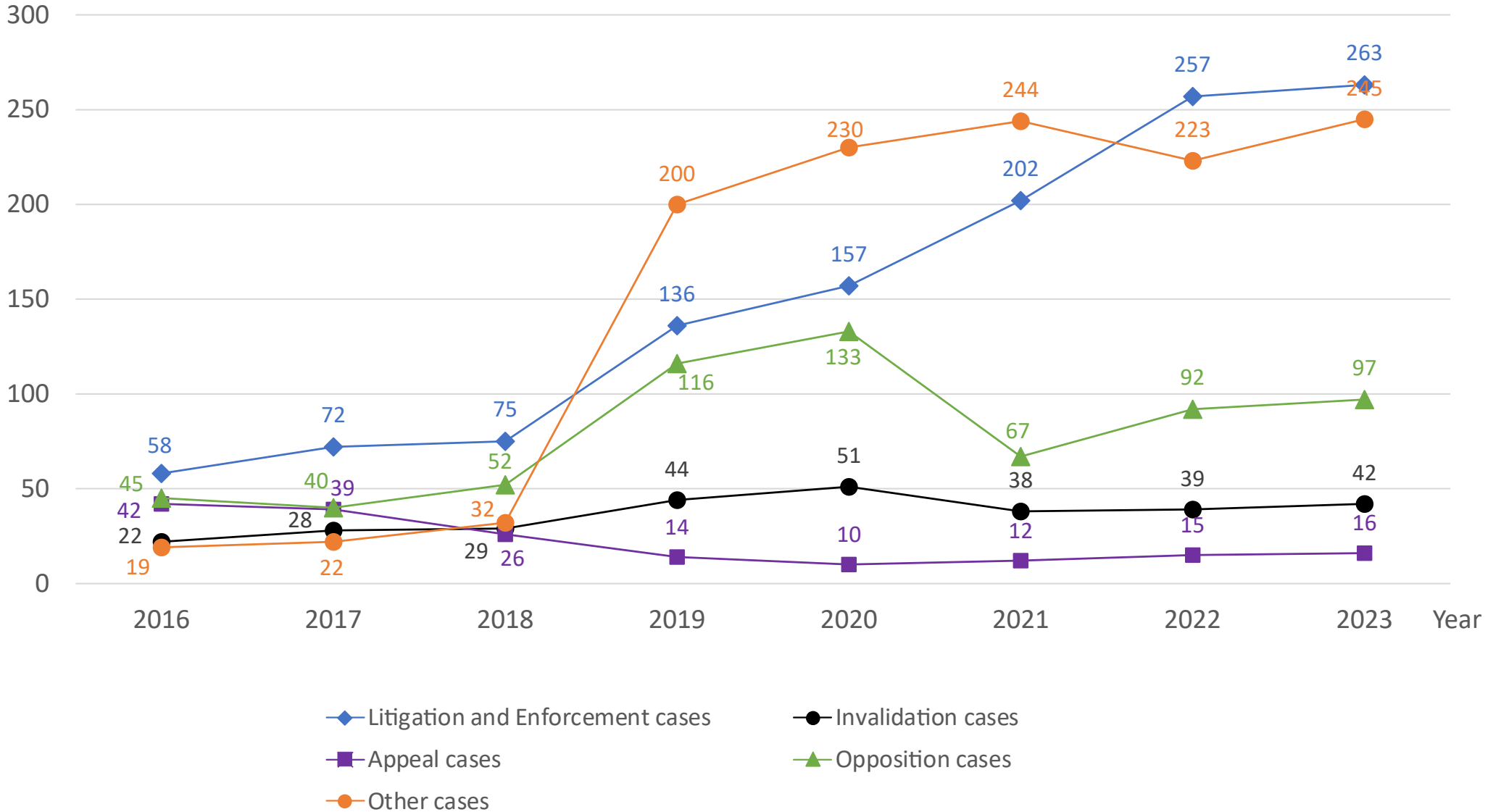
